Clarion West's mission is to support emerging and underrepresented voices by providing writers with world-class instruction to empower their creation of wild and amazing worlds. Through conversation and public engagement, we bring those voices to an ever-expanding community.

Form 990, Part III, Line 4a - Program Service Accomplishments

In 2025, Clarion West held 22 free public events, including alumni writing sessions, author events, open mics, and alumni readings. Seven of these events were held in-person around the Greater Seattle Area, including at Third Place Commons in Lake Forest Park, Common Objects Seattle, Seattle Public Library Central Location, Hugo House Seattle, and Magnuson Park Amphitheater. We also held several low-cost classes and workshops for writers in-person. Across all of our programs so far this year, the organization had 1,873 program participants. The free summer reading series had 309 attendees and two of these were held as hybrid events, with readers in Indiana and New York. We launched a Novel Writing Workshop this year, focusing on bringing 12 emerging writers from an initial idea to a full first draft of their novel. The application process was highly competitive and participants feel that the program has been successful, with 9 out of 12 participants completing their novel drafts within the first 10 months. Clarion West has held its signature six-week intensive writing workshop for the 43rd year. This year, we used a new format that aimed to improve the virtual experience and better assist writers through the intensive boot-camp style program. The overall consensus was that this format led to better outcomes. One participant wrote, "Attending Clarion West was a wonderful experience! I felt very nurtured and my classmates, instructors and facilitators, challenged me to do better. CW made me a more confident and thoughtful writer."
